Don Meichenbaum, Ph.D., is Distinguished Professor Emeritus, University of Waterloo, Ontario, Canada from which he took early retirement 15 years ago to become research director of the Melissa Institute for Violence Prevention and Treatment of Victims of Violence in Miami. (Please see www.melissainstitute.org that has had over 2 million hits worldwide). He is one of the founders of Cognitive Behavior Therapy. In a survey of

clinicians reported in the *American Psychologist* he was voted "one of the 10 most influential psychotherapists of the 20th century." He recently received a Lifetime Achievement Award from the clinical division of the American Psychological Association and was an honorary president of the Canadian Psychological Association.

He has presented in all 50 U.S. states and internationally. He has published extensively and most recently published *Roadmap to Resilience: A Guide for Military Trauma Victims and Their Families* (visit www.roadmaptoresilience.org). His other books include *Treatment of Individuals with Anger Control Problems and Aggressive Behavior*; *Stress Inoculation Training*; *Facilitating Treatment Adherence*; and *The Unconscious Reconsidered*.

He has consulted for various populations including veterans' hospitals, the National Guard, psychiatric treatment centers for children, adolescents and adults, treatment center for individuals with traumatic brain injuries, torture victims, Native populations, deaf populations and school boards.
