Objectives

12. Perform early management of cardiac arrest until termination of resuscitation or transfer of care.
13. Evaluate resuscitative efforts during a cardiac arrest through continuous assessment of CPR quality, monitoring the patient’s physiologic response, and delivering real-time feedback to the team.

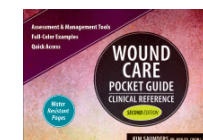
