Treatment Strategies for Redeveloping Neuropathways

Visual perception skills to:

- Keep up with note taking in class
- Remember multi-step instructions
- Remember the order of letters when spelling a word
- Remember how to do homework once at home

Memory skills/phonological awareness to:

Remember more than 1 or 2 instructions at a time

Interpret words as they were intended: cat verses hat

Spell aloud

Visual skills to:

- Discriminate different fonts
- Form letters or numbers

Not write letters or numbers backwards

Help with mixing up letters/ numbers - /d/ from /b/ or /E/ from /3/

Find their pencil in their desk Find matching socks when dressing
